Weather permitting and providing the event does not require professional dress:

For Members and Advisors:

Skorts, pants, jeans, or shorts may be worn when appropriate for the activity. Pants, jeans, and shorts must be in good taste and appropriate. Tasteful ripped jeans without skin showing may be worn. Length of skirts, skorts, or shorts must be no more than two inches above the knee.

Shirts must contain no print that is offensive or controversial.

Attire that is not appropriate:

Short shorts, tight jeans, miniskirts, halter tops, tube tops, tops exposing midriff, spandex shorts/pants, sweatpants, and pajamas.

**GENERAL
APPEARANCE**

Proper undergarments must always be worn and not visible.

Hosiery is suggested when wearing meeting or formal attire.

Body piercing jewels other than earrings should not be worn at Rainbow functions.

Hair should always be worn neatly.

FOR BUSINESS MEETINGS

For Members and

Advisors:

Females: Dress, dress pants, or skirt and blouse or Rainbow t-shirt may be worn of any color if it does not exceed more than 50% black or other dark colors. Your choice must look and be considered tasteful and appropriate.

Length of dress or skirt should be no higher than two inches above the knee. Dress shoes are recommended.

Males: Dress pants with dress shirt or polo shirt.

Attire that is not appropriate:

Jeans, tight pants, miniskirts, t-shirts with print that is offensive or controversial, halter tops, tube tops, tops exposing midriff, spandex shorts/pants, sweatpants, and pajamas.

INITIATIONS, INSPECTIONS, INSTALLATIONS, SCHOOLS OF INSTRUCTION, AND SPECIAL OCCASIONS

For Members:

Formal dress, floor, or tea length are to be worn. Your choice must be considered tasteful, appropriate, and have a non-revealing neckline.

Dress may be of any color if it does not exceed more than 50% black or other dark colors. It can have spaghetti straps or a two-inch halter-like strap.

Back of dress should not fall below the natural bra line. Slit in dress may not exceed the knee.

Neutral colored sweaters are acceptable.

Dress shoes are recommended.

For Candidates:

Formal or short dress is appropriate. Length of dress should be no higher than two inches above the knee.

Dress may be of any color if it does not exceed more than 50% black or other dark colors. Dress shoes recommended.

For Advisors and Guests

Females: Dress or skirt and blouse may be worn. Mother Advisors must wear a formal dress.

Men: Dress pants with a dress shirt and tie. Jacket is optional.

Dress shoes recommended.

Flip flops or shoes without a backstrap are not to be worn.

SWIMMING ATTIRE

Bathing suits may be a one-piece or two-piece providing the suit is in good taste and not revealing. In hotels and other facilities, cover-ups and appropriate shoes must be worn when traveling to and from the pool.
